PREMIUM AGREEMENT

UPMC | **SALVATOR MUNDI**

Between **UPMC | Salvator Mundi International Hospital**
and **AMBRIT INTERNATIONAL SCHOOL OF ROME**

1. What is Premium Agreement

PREMIUM agreement guarantees a **facilitated path** of access to an assistance of quality provided by UPMC|SMIH for all those who belong to the Affiliated Organization, as indicated in point 2 below, **providing privileged economic and organizational conditions**.

All the services provided by UPMC|SMIH will be available in compliance with the conditions of this agreement and will be activable compatibly with the actual availability of beds, services and organizational needs.

2. Beneficiary Subjects of the agreement

The following beneficiaries (so-called "**Beneficiary Subjects**") can access the facilitated conditions:

1. those who have a direct relationship with the affiliated Organization (managers, directors, collaborators, employees and/or members);
2. other subjects to be identified at the specific request of the Organization (visitors, Institutional Representatives, spouse or cohabiting partner and first degree relatives) previously authorized by UPMC|SMIH.

The beneficiary Subjects, to be recognized in the different phases of booking, admission and, in any case, before the issue of the payment invoice, are required to present a valid Identity document and demonstrate their membership to the Affiliated Organization (through the badge or photocopy of the cohabiting partner's badge).

3. Economic Conditions reserved to "Self-paying" Beneficiary Subjects:

For Self-paying Beneficiary Subjects the following conditions are applied:

- **20% discount on UPMC|SMIH price list for:**
 - Diagnostics (cardiology and diagnostic imaging);
 - Laboratory tests;
 - Physiotherapy.
- **15% discount on UPMC|SMIH price list for:**
 - Day hospital;
 - Hospitalization (on all the rooms, except those on the 4th floor);
 - Operating Room;
 - Medication treatments performed at the "First Aid" room.
- **10% discount on UPMC|SMIH price list for:**
 - Standard and personalized Check-ups.

4. Premium Agreement validity

The Agreement will be tacitly renewed from year to year, subject to cancellation to be sent, by both the Parties, by certified electronic mail, at least 60 days before the deadline.

With regard to what is mentioned above, UPMC|SMIH reserves the right to withdraw and modify at any time the conditions of this agreement (including the economic ones) through a simple written communication, which will be sent to the Affiliated Organization.

The same Organization will have to promptly inform its Beneficiary Subjects with regard to any modifications made.

We confirm that the services delivered after the aforementioned modifications or after the withdrawal has become effective, will still be subject to the conditions in force at the time of their booking.



5. Access to the Services related to the Premium agreement

The conditions of the Premium agreement are valid only if the booking and admission are made through the specified offices and not through direct contact with the doctors.

To simplify and facilitate the access to the services, UPMC|SMIH assigns the following interlocutors to the Affiliated Organization and its beneficiary subjects.

OUTPATIENTS RESERVATION (clinical investigations and diagnostics):

With regard to **URGENCY** and contacts per email, you are kindly requested to specify "**URGENCY**" in object!

Our "in urgency" services provide the assignment of a Physician Tutor to the patient, who performs the functions of «General Practitioner » and will carry out "counseling" to start and manage the best medical pathway possible.

UPMC|SMIH provides "in urgency" services also for all those who come without prior notification, with the limitation to simple pathologies or traumas, classifiable as green and white codes (not poly-traumas).

For administrative information: The contact person dedicated to you is **Adv. Ugo Canali**, (tel. **06.588.96.900**, email: **smih.premium@upmc.it**), charged with the task of facilitating the access to the hospital and/or assisting in case of eventual needs related to this agreement.

For the identification of the doctor and the diagnostic and therapeutic pathways: The person of reference is the Medical Director, responsible for the management and coordination of the medical health activities (**Dott. Bruno Casaregola**, tel. **06.588.96.900**, email: **casaregolab@upmc.it**), who operates as «Supervisor» and will assign the physician of the clinical specialty related to the patient's needs.

6. PROCEDURES AND TERMS OF PAYMENT

6.1 Payment directly executed by the Beneficiary Subject ("the patient")

A) In case of "INPATIENT":

At the time of the Inpatient Admission at our hospital it is requested a DEPOSIT of the 50% of the budgeted amount or the amount "communicated" from the same "Inpatients Admission office" (where it has not been possible releasing the budgeted amount). The payment of the remaining balance will have to be executed at the time of dimission (exit) from UPMC|SMIH.



B) In case of "OUTPATIENT":

The payment of the whole amount will have to be executed immediately, at the time of his/her Admission at UPMC|SMIH.

6.2 Payment executed by the Affiliated Organization in favor of the beneficiary Subject ("the patient").

The Affiliated Organization must previously send UPMC|SMIH the **authorization document "Taking Charge of the Healthcare Expenses"** (Annex 1, an integral part of this agreement), on letterhead, duly completed in all its points and signed, before the admission of the beneficiary Subject (the patient) at our hospital, to the following addresses:

A) In case of "INPATIENT": smih_ricoveri@upmc.it

The affiliated Organization will execute the balance's payment upon invoices' receipt.

PLEASE, KEEP IN MIND, where the hospital will not have received the aforementioned **"Taking Charge of the Healthcare Expenses"** document (Annex 1), the patient will have to execute the payment of the DEPOSIT (the 50% of the budgeted amount) immediately, at the time of his/her Admission, and the payment of the BALANCE at the time of his/her dimission (exit) from the hospital.

B) In case of "OUTPATIENT": smih_docs@upmc.it

The affiliated Organization will execute the balance's payment upon invoices' receipt.

PLEASE, KEEP IN MIND, where the hospital will not have received the aforementioned **"Taking Charge of the Healthcare Expenses"** document (Annex 1), the patient will have to execute the payment of the TOTAL amount immediately, at the time of his/her Admission.

C) For all the services to be delivered "IN URGENCY":

in those cases, where, in the period of hospitalization (or execution of outpatient services) of its member, the affiliated Organization will not send UPMC|SMIH the aforementioned **"Taking Charge of the Healthcare Expenses"** document (Annex 1), on its letterhead, duly completed in all its points and signed, the patient will have to execute the payment of the TOTAL amount of the healthcare services received.

Privacy:

With reference to EU Regulation 2016/679, the Organization - which for purposes of payment of the agreed amounts is the recipient of UPMC|SMIH billing documents and of any other clinical document referring to the beneficiaries of the services under the present Agreement - shall act as autonomous data controller and, in compliance with art. 13 of the above Regulation, shall inform independently and in advance the beneficiaries of the modalities and purposes of data processing, obtaining their relevant consent, if necessary.


9. Communication
